In a boon to street vendors in
Bengaluru, the Supreme Court has

asked the state government to make it obligatory to give licence to them to continue business in the city. The court has given a judgment of more than 2,500 words on what is known as ' ' or 'pitha' trade. However, it has not issued any order in the matter. The president of Karnataka Bar Council, R. Ramana, and Chief Bar Councilor Kaviraj have filed separate applications in the apex court saying the trade is causing environmental pollution. The counsel representing the state government told the court that the state government had issued an

order to issue licences of between Rs.10,000 and Rs. 50,000 to street vendors to make their business economic and sustainable.

However, the counsel also said that the state government had no power to pass such an order. The court had earlier allowed the street vendors of Bhatkal, Mangaluru, Hubballi-Dharwad and Udupi to continue their business as they had been directed by the High Court to desist from the trade. The High Court had on September 23, 2009, directed them to be evicted from all the municipal markets. The Karnataka

High Court had, however, vacated the directions to evict them on the ground that it was not possible to eliminate these workers without affecting the cause of the poor. The High Court had passed a similar order on the same issue on April 25, 1999. In the earlier order, the High Court had directed that all the officers deputed on the direction of the Deputy Commissioner of Police, should give three months' notice to the street vendors to shift their shops on the ground that they did not have the permission to run the shop. "There should not be any

shop run by any street vendor at any municipal market, unless they have been issued a licence by the Deputy Commissioner of Police. The government should provide the licence on the basis of the income and self-employment,” the High Court order said. Meanwhile, the street vendors of Bengaluru have been praying for the decision. They had said that the city's government was not taking any decision on the issue, which was causing inconvenience to them. “Though the authorities keep issuing warnings and notices against begging, the government

has never taken any decision on the issue, which is causing hardship to us,” said Sujay f988f36e3a
