motions are forms of parliamentary procedure that provide information on a matter which is then read aloud to the body. if the motion is "submitted," the matter is then given consideration. if the motion is "seconded," the chair can direct the body to deliberate on it or debate the motion. the chair can suspend debate, order voting on the motion, or close debate at any time during the meeting. roberts rules of order advises the use of the united states constitution, the federal and state constitutions, and the united states code as guides. however, each state has its own constitution, and each state has its own laws and regulations. therefore, roberts rules of order does not cite to every state's laws and regulations, but only to those that cover the context of the discussion or procedure being presented. therefore, each state has the authority to enact its own laws and regulations when necessary. when citing a state's laws and regulations, it is critical to be aware of those laws and regulations that are in effect at the time of the meeting and the location of the meeting, or else the laws and regulations may be different than those cited. roberts rules of order recommends the use of an agenda, but does not offer any specific tips on how to organize an agenda. in general, a good agenda has a list of items to be discussed, and a list of items the chair will keep moving until all items have been addressed. this will allow participants to focus on the items of highest importance, and allow all members of the group to be heard.

Bar associations maintain formal disciplinary records that are usually filed with a court where a lawyer's license to practice may be revoked

or suspended. Courts often order that the records be destroyed if the lawyer's disciplinary case is terminated by an order of suspension or disbarment. This means the lawyer will no longer be eligible to appear pro hac vice and would therefore be prohibited from representing clients in a New York case. In other situations, a lawyer may voluntarily withdraw, and then later seek reinstatement. In either case, there may not be a record of the disciplinary proceeding. Thus, lawyers who seek to reinstate their right to practice must compile a record of their discipline as evidence of their moral character. This is called a "submission of evidence." A submission of evidence typically has been filed by lawyers with the state in which the lawyer lived and practiced when the suspension or disbarment occurred. If the lawyer moved to a different state, some state bar associations now require the lawyer to provide a copy of the evidence to the bar association in the new state.

For FINRA members, unscreened calls are the best method to determine if your broker or firm is operating properly. DO NOT use your normal order to cancel a call: if you don't know how to place a secure order, your first call might not be to the firm's OCC or the firm's Clearing Member. Do not call brokers or firms outside your firm. FINRA does not handle customer complaints, and FINRA cannot provide quality control or quality assurance. A court may intervene to resolve a conflict that cannot be arbitrated (for example, if the panel to be appointed was not impartial). The court appoints a new panel, and the arbitration proceeds, either with a new panel or the same panel. A court can also intervene to resolve a dispute among parties to an arbitration agreement. Such a dispute may be the subject of a separate arbitration or may be resolved in the pending arbitration, with a court order requiring the parties to engage in discovery to see if an agreed-upon arbitrator is available. 5ec8ef588b
