the supreme court of the philippines has also set up an information technology division to "develop, maintain, and provide online access to the court's case file system and websites." the goal is to provide comprehensive and accurate information to the court's users. the provision of such information is a key factor to ensure that the court is responsive to the needs of its users. the court and its website is the primary source of official court decisions in the philippines and is the most complete source of official legal information in the country. the philippine constitution, which was drafted by the constitutional commission (now the philippine constitution commission) under the constitution of the philippines, is the highest law of the country and contains the highest form of law. it is the supreme law of the country (art. 1, sec. 1). it is also the only source of law which is not subject to interpretation, change or repeal. it is the only source of law which cannot be amended. the constitution is the basic law of the philippines and is supplemented by all other laws passed by the congress of the philippines, the other branches of government, and the administrative agencies (art. 2). the constitution sets out the basic structure and system of government of the republic of the philippines, and is the primary source of law governing the relationship between the people and their government. it is the fundamental law of the country, and to that extent all other laws must conform. the constitution is the supreme law of the country, and is supplemented by all other laws. it is the basic law of the philippines, and to that extent, all other laws must conform. 5ec8ef588b
